Discussion:

The Spring 1 Summary for Reading, Writing and Maths was available to view. This shows progress towards ARE with FFT estimates included. CT stated she needed to check that this only includes children that are still in our school and that our new children have been included.

- ➤ Gov Maths Yr 3 What are we doing?: There is an issue with test preparation. We need to ensure they are using SMaths methods to get them to answer questions.
- ➤ Gov Write Yr 5?: This is a class of two halves. One group are above were they need to be, the others need boosting they will get individual tutoring Groupings will be looked at again after SATS.
 - ➤ Gov Write Yr 4&5 do we need to put something extra in place as Yr 3&6 seem to be ok?: Teaching of writing is a known issue with some staff they have been receiving extra support.

Spring 2 for Yr 4 is currently in line with FFT. Governors took the opportunity to review the Yr 4 assessment and journal books.

➤ Gov - Is this demonstrative of the level in this class or the better ones?: They all need to have the same expectations e.g. handwriting as well as content

CT stated that Teachers need to remember assessment changes rather than levels. CT & KD-J have done moderator training with the LA so these ideas have been brought back to be used in school: Align, understand and work in uniform way - Outcomes are good as children can see their progress and story.

We are ready to accelerate SMaths and this is being started in Inset 3.

➤ Gov - Have heard good responses from parents regarding after school provision. Tutoring is going well and Yr 5 are keen to attend.

PM - meetings are currently underway for mid-point.

Counselling is working well - can see improvements in children - hope to keep this going next year.

CJ has emailed CT today with questions she feels need clarifying for Safeguarding

HMI letter arrived today and this was shared with Governors.

- ➤ Gov Does this go to parents?: Yes
- ➤ Gov The outcome Are we effective or not in making changes?: Yes, he was happy we know our school
- Gov Could we send out with a cover letter again to make sure the good points are highlighted

SIP Priorities - worked well to be able to answer questions. Gov would like to be able to talk stats and understand them better - would like to know her area better. CT stated that it would work well if govs could book time and NH who could create a doodle with suggested time slots. Questions to be challenging and preferably submitted in advance. The inspector felt one of our policies on website was dated. This needs to be checked.

Discussion

- Period 9 was looked at in the last meeting. Budget is challenging, with financial constraints upon us. Bursar has shuffled finances with small impact upon staff.
- New estimate changed figures are coming in shortly. We thought the staffing option chosen at P9 was not going to work. However the P12 tab has shown different figures, with a significantly different underspend. Whilst we are still crunching data, we need to alert staff (1st notice) of an impending deficit budget position. This gives us a couple of week's leeway before making final decisions.
 - ➤ Gov What is the notice period? : The pool of staff being considered is the TA pool, which requires 3 months. We need more teachers with their expertise and leadership availability. We have already spoken to Unison and would pay notice period if we miss the end of May deadline.
 - ➤ Gov Is there any indication of anybody wanting to go voluntarily?: Not that we are aware
 - Gov We know how hard the teaching team are working we have a good team of staff
